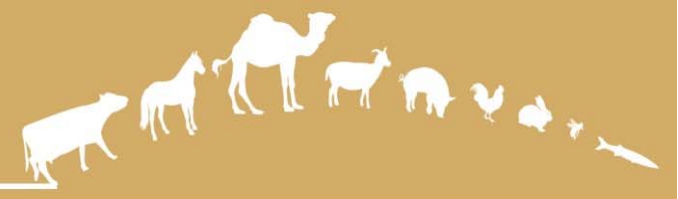

Vision for the Eastern Africa Roadmap for FMD: 2012 - 2022

An East African region in which FMD will be under control and approaching disease freedom (PCP-FMD Stage 3) in the majority of member states by 2020, with zonal or country freedom (PCP-FMD Stage 4) being reached in some parts of the sub region

- First developed during the FAO/OIE/AU-IBAR Meeting of regional FMD experts and institutions, held in Jan. 2009
- The regional FMD Roadmap meeting provided an opportunity to review progress ahead of the Global Conference on FMD Control organised by FAO and OIE in June 2012

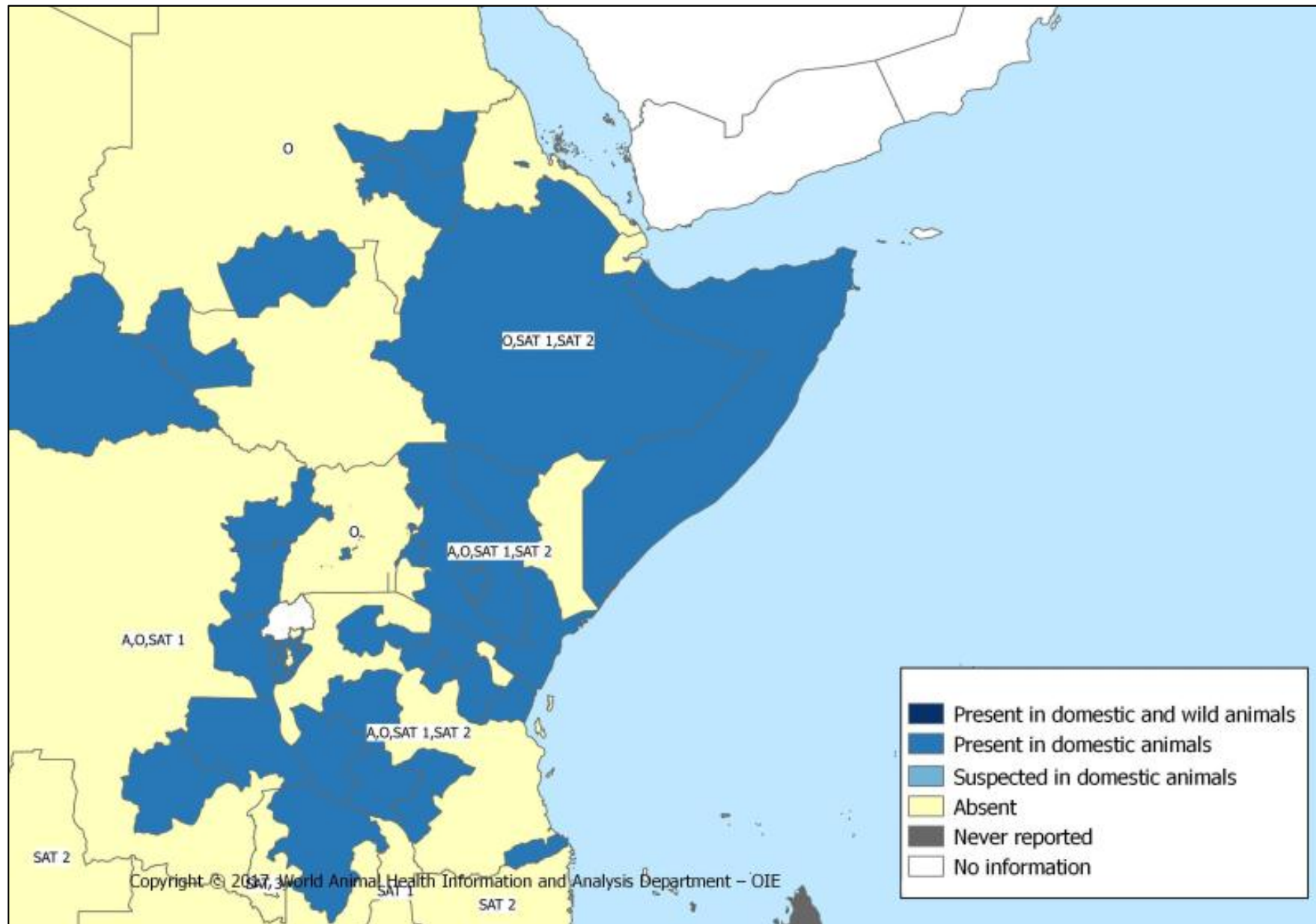

FMD Roadmap for Eastern Africa...

- Rwanda considered it possible to reach FMD freedom without vaccination by 2022 as it had not encountered clinical FMD since 2005.
- Eritrea, Ethiopia and Tanzania (zonal) consider it feasible to achieve FMD freedom with vaccination by 2022. Moving up to Stage 5 (FMD freedom without vaccination) was not considered because of wildlife carrying FMD virus.
- All other countries except for South Sudan and Sudan (zone B and C), aimed to move up to PCP-FMD Stage 3 by 2022.

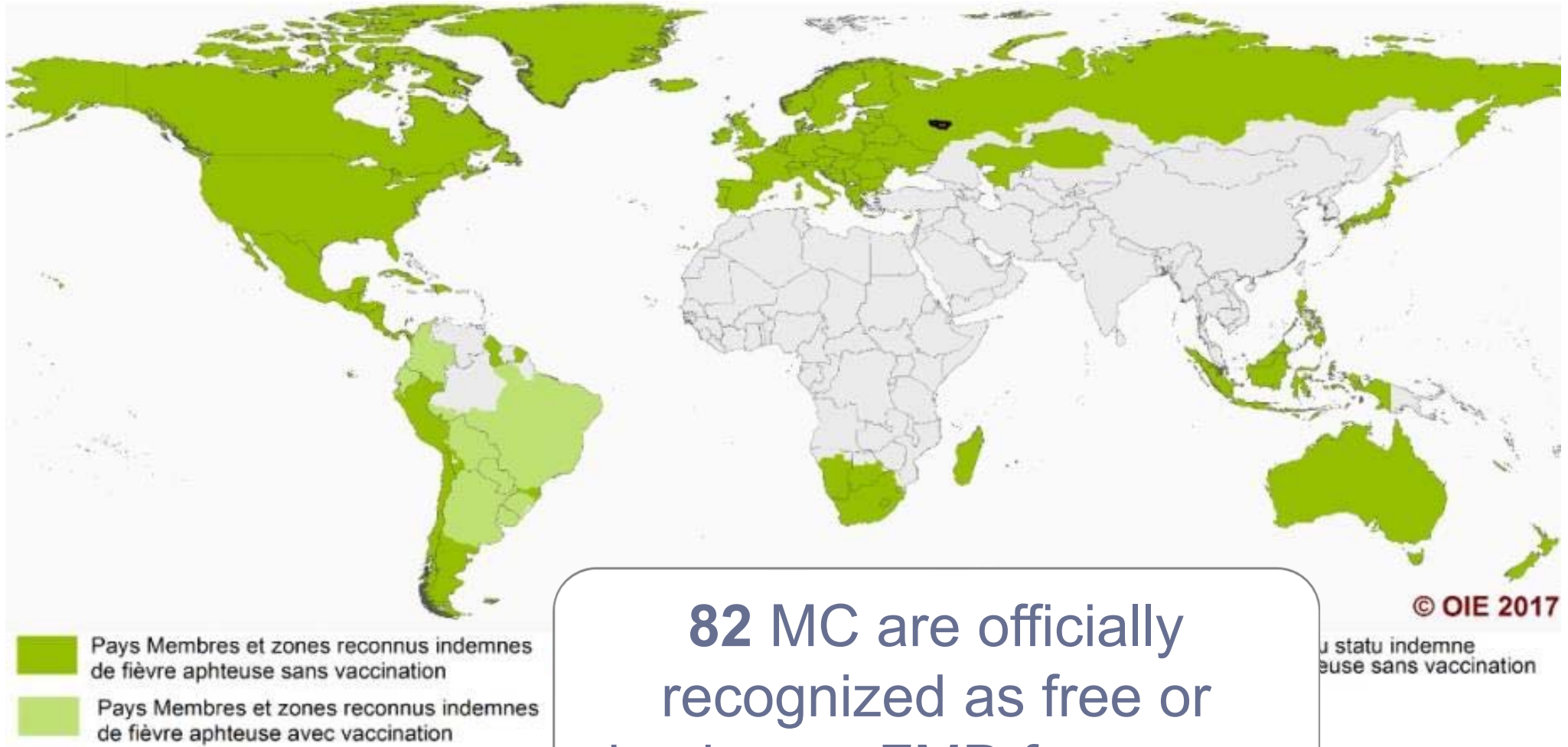
FMD situation in Eastern Africa

Recommendation from 7th EARAHN Meeting (4 -7 Oct. 2016)

Considering that several running Priority diseases control efforts in the region are supported by various donors:

- there is a need to share country implementation progress, experiences and challenges.
- This is to facilitate country performance re-assessment as per OIE/FAO PPR control and eradication pathways such as PPR GCES and PEP and FMD-PCP (action by AU-IBAR, FAO, OIE and RECs to take lead and facilitate the processes)

Cross-sectional surveys for CBPP, FMD, PPR and RVF in IGAD Member States: 2015 - 2017

Cross-sectional surveys comprising of clinical, questionnaire and serological investigations supported under the STSD Project conducted in:

- Djibouti
- Eritrea
- Ethiopia
- Kenya
- South Sudan
- Sudan
- Uganda

Information could assist in updating FMD Roadmaps

- **Sudan position been evaluated to be in stage 2 of PCP-FMD in 2014 and up to 2017**
- **Stage 3: from 2018 – 2022**
- **Stage 4: 2023 – 2024**
