



## Highlights of LEGN's support activities on animal health legislation in the African region

- Support for the veterinary laboratories initiative in the framework of the VetGov Program: analysis and update of veterinary laboratories legislation in Kenya
- Support for the review and update of (i) animal health and (ii) veterinary professions legislation in Angola
- Support for the revision of veterinary drugs legislation in Mozambique
- Revision of draft animal health legislation in Namibia
- Support for the drafting of an animal identification and traceability law and regulations in Swaziland
- Support for the drafting of an animal health and production act in Capo Verde;
- Support for the drafting of veterinary profession legislation in Egypt and in Rwanda;



## LEGN's support for the drafting of a regional regulation on animal health for the CEMAC

- Funding: FAO (technical cooperation project)
- Partners: CEBEVIRHA (*Communauté Economique du Bétail, de la Viande et des Ressources Halieutiques*)/CEMAC in close collaboration with the ministries in charge of livestock in the 6 member countries
- Expected results: A new regional regulation on animal health and safety of food of animal origin with direct applicability to the Member states; A plan of action for the implementation of the regional regulation; Launching of a process to raise awareness on the new regional regulation
- Resources:
  - 4 national consultants (animal health, veterinary drugs, food safety, legal) for each country
  - 4 international consultants (same areas as above)
  - 5 FAO officers (3 Animal health and production officers (HQ, regional and sub-regional office), 1 food Safety officer and 1 Legal officer)
  - 6 FAO country offices
  - 1 Project coordinator from CEBEVIRHA
- Timeframe: 18 months

## CEMAC work - methodology

**Step 1.** Diagnosis, baseline assessment, first orientations

*1.a. Baseline assessment from an institutional and legal point of view (collection of existing national and regional texts and analysis of the role of existing institutions, looking at opportunities, gaps and overlaps)*

*1.b Formulation of recommendations (form and substance)*

*1.c 1 regional workshop*

**Step 2.** Legislative drafting process

*2.a From the recommendations, lawyers and technician discuss the regulatory points/objectives*

*2.b Provide legal proposals in line of the legal and normative structure of CEMAC*

*3.c Comply with basic principles (compliance with constitutional norms, international conventions, international standards, established community norms)*

## CEMAC work - methodology

**Step 3.** Improving and validation of the text

*3.a 6 national workshops*

*3.b Consolidation of the document in light of the outcome of the national workshops*

*3.b 1 regional validation workshop*

**Step 4.** Finalization and submission

*4.a Consolidation of comments and recommendations provided during the validation workshop*

*4.b Final review by the international legal expert*

*4.c Technical clearance by AGAH, AGN and LEGN and submission of the text to the CEBEVIRHA*




## Highlights of LEGN's role in FAO's multidisciplinary one health approach: Anti-Microbial Resistance

Under **Resolution 4/2015**, the conference requested FAO to support related regional, national and local efforts as well as deepen its partnership in this effort with the World Health Organization (WHO) and the World Organisation for Animal Health (OIE) – focusing in particular on helping lower-income countries develop the capacity to respond to the AMR challenge

The **FAO Action Plan on AMR** addresses four major Focus Areas:

- improve awareness on AMR and related threats;
- develop capacity for surveillance and monitoring of AMR and AMU (antimicrobial use) in food and agriculture;
- strengthen governance related to AMU and AMR in food and agriculture;
- promote good practices in food and agricultural systems and the prudent use of antimicrobials.



## Support to FAO work on AMR


Antimicrobial usage in humans, animals and agriculture, and resulting dispersion of antimicrobial residues into aquatic and terrestrial environments (●●)

Antimicrobial residues result in resistant bacteria. Resistant bacteria are increasingly found in Humans, animals and the environment
