

## Outcome of the PVS evaluation – Important facts that have to be noted

- The responsibility of a Veterinary Services is not only the mandate of DAFF.
- An independent PVS audit provided:
  - A clear motivation for all stakeholders to work together to improve Veterinary Services
  - Provided an unbiased input to political principals on resource needs of Veterinary Services
  - Provided trade partners with information on the efficiency of the RSA export system of animals and animal products







#### **OIE GAP** analysis of South Africa

- The GAP analysis took place from 16 to 27 June 2014
- This provided more detailed information on the aspects that were evaluated during the PVS evaluation.
- Veterinary Services were included in a combined evaluation (WHO/OIE/FAO) of the International Health Regulations core capacities of South Africa.



#### **ACTIONS TAKEN AFTER THE PVS AND GAP ANALYSIS**

- A Veterinary Strategy was developed and signed off in 2017.
- The aim of this strategy is:

 To provide a science based, socially responsive and coherent veterinary services, that manages disease risks associated with animals, their products while ensuring the welfare of animals and securing food safety for the consumers

 All role-players were consulted and involved in the drafting of the Veterinary Strategy


