





The OIE PVS Tool




Structure of the OIE PVS Tool



What has worked? - TO KEEP!

- independent, external process
- voluntary, country driven process targeting internal systems/resources for sustainability
- effective and efficient tools/methods, with a firm basis in OIE's internationally

What has worked? – TO KEEP! (2)


- excellent institutional access via OIE's role & reputation
- a culture of being participatory, supportive and collaborative, not directive or presenting a risk
- a properly broad-based systems approach, covering all threats, including emerging diseases



Basic PVS Principles – also to keep!

- Continuous process to sustainably improve national VS
- > External and independent:
 - > Experts trained and certified by the OIE
 - > Based on facts & evidence, not impressions
- Official request from OIE National Delegate => voluntary
- > Purpose:
 - Assess compliance with OIE standards via PVS Tool
 - > Identify strengths / weaknesses and areas for improvements
- Reports = country property (confidentiality of results, unless agreed)
- > Supportive not directive, strong platform for planning & advocacy
- Capture better the real impacts in improved budgets, staffing, infrastructure, governance arrangements, technical capacity etc in many countries (see business case for examples)







2. Evaluation (new options)

2c) PVS Self Evaluation:

- Always available, now formal OIE option
- OIE support via training sub-regional
- National training <u>may</u> be possible if committed to self-evaluation i.e. decentralised level
- Tool adapted to sub-national application, teams and timing up to country
- The OIE, or any other external agency, NOT involved in the mission or report
- PROS greater detail, ongoing monitoring, flexibility & control
- CONS objectivity, engagement outside of VA

2e) PVS Specific Content:

- Links PVS systems focus to a real life priority issue or disease, demonstrating applicability
- AMR different approach >> TOOL Competency
- PPR method piloted, finalised & being rolled out - LINKS TO PMAT

3: PVS Strategic Planning Support (new)

- PVS Gap OIE team working with a country's Veterinary
 Authority to develop a detailed VS strategy over five years
- Some countries find it difficult to use issues with formatting, interpretation, translation, tasking...
- Many countries have a formal strategic planning cycle for Veterinary Authority or relevant sector, but many don't...
- Logical to link the two opportunity of PVS support to initiate 5 year strategic planning cycle or update existing cycle
- PVS provides holistic and comprehensive inputs/process –
 via a template approach

4A: OIE PVS and WHO IHR One Health Linkages

'Equivalent' systems targeting international:



4B: Veterinary Legislation + 4C: Sustainable Labs + 4D: Vet/VPP education + 4E: Focal Points training

- VLSP ongoing, provides focused support in key areas e.g. VSB/VPPs, AMR, Biothreats
- Sustainable Labs balances personnel, infrastructure, equipment, operating, sampling costs with national VS needs
- Vet education/VPPs covered at workshop on Mon & Johan Oosthuizen yesterday
- National Focal Points biannual training model, currently being reviewed

4F: Public Private Partnerships

- Consultative process to develop OIE Guidelines for PPPs in the veterinary domain
- Identifies 3 types of PPPs transactional, collaborative, transformative
- Structured as: 1. Strategic rationale, 2. Executive briefing and 3. Implementation guide. Includes case studies, ethical charter, enabling environment....
- Will be finalised and launched at OIE GS this year
- Sub-regional OIE PPP workshops planned in Africa;
 Addis Ababa July 2019 and Tunis Sept 2019


