#### DECISION n° 2017-10

Annual update of contacts in ministries responsible for foreign affairs and ministries responsible for following up OIE activities in OIE Member Countries

Considering that it is vitally important for all correspondence emanating from both OIE Headquarters and the Regional and Sub-Regional Representations to be sent to the appropriate authorities and addresses.

Considering that, in many OIE Member Countries, there may be frequent changes in names and addresses of ministries and that the assignment of ministries responsible for following up OIE activities may change.

More rigorous monitoring of information in the TIGER database is needed to avoid protocol errors when sending correspondence to OIE Member Countries.

Considering that the Regional and Sub-Regional Representations are in direct contact with the countries of their respective regions and that it is therefore much easier for them to obtain updated information on any changes that may have occurred within the official institutions of OIE Member Countries.

The General Directorate has decided to assign Regional and Sub-Regional Representations with the task of annually verifying contacts in the different ministries (ministry responsible for foreign affairs and ministry responsible for following up OIE activities). The Regional Representatives and Sub-Regional Representatives will be responsible for providing an update of all the data on these ministries in the first half of November every year. This verification will allow correspondence relating to the General Session and to any other relevant OIE activity, such as Regional Conferences, to be dispatched appropriately.
