




# Minutes of the 10<sup>th</sup> Regional Steering Committee Meeting

#### 10<sup>TH</sup> GF-TADs for Africa Regional Steering Committee (RSC) meeting

- 6 8 October 2021 (9th GF-TADs meeting held in 2014 in Ouagadougou, Burkina Faso)
- Hosted by Nairobi Kenya
- Virtual
- **Attendance**: up to 57 participants

#### **Session 2: Governance aspects (2)**

  - Dr Adama Diallo, Chair of the PPR Global Research and Expertise Network (GREN) on revision process of the PMAT).
  - Dr Hiver Boussini from AU–IBAR presented the Pan-African PPR Control and Eradication Programme.

Note: The representative of the EU offered to consider priorities brought forward as long as such priorities are backed up with political will. The AU was tasked to take lead and galvanize support for priorities in view of the Africa Summit 2022.

#### Session 5: GF-TADs for Africa Regional Strategy 2021 - 2025

**Presentation of the draft Regional Strategy 2021 - 2025 : by** Dr Patrick Bastiaensen on behalf of the GF-TADs Regional Secretariat The priority diseases under GF-TADS of regional importance are:

- ✓ Foot and mouth disease
- ✓ Peste des petits ruminants
- ✓ African swine fever
- ✓ Rift Valley fever
- ✓ Contagious bovine pleuro-pneumonia

#### Discussion in break-out rooms (according to language)

Two groups (French speaking and English-speaking group) to brainstorm on two topics; the four objectives of GF-TADS Regional Strategy 2021-2025, and critically review the actions plans for PPR, ASF and CBPP.

Quorum not obtained: Decision: document to be updated by incorporating the group discussion inputs and will then be submitted for electronic voting.

- Discussions and adoption of RSC-10 recommendations, dates and venue/format of the RSC-11




#### Two decisions:
