Introduction

The World Organisation for Animal Health's *Terrestrial Animal Health Code* (TAHC) provides Members with detailed guidance on how to conduct safe international trade of animals and animal products and successfully access foreign markets. While grounded in sound science, these regulations can also be quite complex to implement and therefore capacity-building has been undertaken on the African continent since 2016 to assist in a better understanding of not only the standard-setting processes, but the best possible use and interpretation of the standards - once adopted - and have so far been supported by two rounds of training, targeting all 54 WOAH Members in Africa.

Whereas the first rounds of training were practical, but generic in terms of species or commodities, and mainly geared towards encouraging Members to take part in the standard setting processes(es), the next (third) round will focus on a specific commodity, in order for participants to dive deeper into the subject matter and apply WOAH standards in a practical manner to facilitate safe trade. In addition, this training round will also be an opportunity to pilot a new user-interface which allows Members to browse current and previous editions of the *Terrestrial Animal Health Code* by commodity and use the search function, rather than by disease or subject (e.g. animal welfare, antimicrobial resistance). The commodity chosen for this third round, poultry meat, is an interesting commodity from various angles. Many of the listed

poultry disease are transmitted by tissue muscle, and in addition, contaminations during harvesting and processing are a considerable food safety and public health issue (*Salmonella*, *Campylobacter*, *E.coli*) and there are linkages to antimicrobial resistance. Poultry meat can be processed in several ways to render it safe and trade facilitating mechanisms such as compartmentalisation and awareness of commodity-based measures are key to accessing export markets.

Expected learning outcomes

The training will also seek to acquaint participants with the use of WOAHP tools such as WAHIS, self-declaration of freedom from diseases and PVS evaluation. Participants will also practise navigation of the digital version of WOAHP standards and explore e-learning modules related to safe trade.

In addition, this training will also aim to strengthen participation of Members from this region in the WOAHP standard-setting process, including a discussion on modalities to enable cooperation between Members, identifying priorities for the region and areas where standards may be strengthened to be fit-for-purpose to meet the needs of Members.

eLearning Phase

The training – in person – will be preceded by two online sessions (webinars) in order to bring participants up to speed with the basics of standard setting, the development of sanitary conditions and import certification. This will – in principle – be mandatory for participants to be eligible for the in-person training in Nairobi.

This training will be intended to achieve:

- enhanced understanding of risk-based trade methodologies and science-based import and export requirements through the use of poultry as proxy commodities.
- Enhanced proficiency in performing veterinary certification and ensuring adherence to international sanitary standards.
- Strengthened comprehension of disease zoning, compartmentalization, and biosecurity protocols as they relate to the poultry meat trade.
- Gained practical expertise in the interpretation of WOAHP Terrestrial Animal Health Code provisions using poultry proxy commodities to improve safe international trade.

Also, participants will be encouraged (not mandatory) to conduct some of the modules of the online training on **Trade of animals and animal products** (CP-12), [WOAHP eLearning platform](#).
