South African Veterinary Council

Regulatory Function

- Veterinary and Para-veterinary Profession Act 19 of 1982
- Custodian of Quality Veterinary and Para-veterinary Standards
- Council and Committees
 - Investigation Committee,
 - Facility Compliance Committee,
 - Education Committee (Standards Working Group),
 - o Committee on Specialization, etc
 - Executive Committee of SAVC and Finance, Audit, Risk Management Committee (FARMCO)
- Executive Management as led by the Registrar/Chief Executive Officer
- Ensuring ethical practices and maintenance of high professional standards














Number of registrees - demographics

Current Workforce Situation

- Veterinarian Shortage in South Africa
 - Only 4 000 registered veterinarians for 30 million people
 - World standard: 200-400 veterinarians per million people
 - Impact on food security and disease control
 - Greater impact on rural smallholder farmers
 - Recruitment of veterinarians experience by private clinics and provincial department













South African Vet Council's Response

- Revised Regulatory Framework
 - Expansion of VPPs' scope of practice
 - Delineation of scope of practice with some aspects of VPPs work on their own, with no supervision and some aspects requiring either direct and/or indirect supervision by a veterinarian
 - Increased visibility in rural sectors
 - Improved accessibility of veterinary services

The SAVC acting in terms of section 30(1) of the Veterinary and Para-Veterinary Professions Act, 1982, promulgated the new rules relating to the practising of the para-veterinary profession of VPPs.

- The New Rules provide for the following
 - General services which may be performed in the course of employment by state, or under veterinary supervision
 - Services that may be performed for own account at a Primary Animal Health Clinic facility
 - Procedures that may be performed by an VPP (Animal Health Technician/ Veterinary Nurse), without veterinary supervision
 - o Exceptions to rule 2













Categories of VPPs

- Five VPP categories and Qualifications registered with SAVC
 - Animal Health Technicians (AHTs)
 - o Primary Animal Health Care (PAHC)
 - Disease prevention and biosecurity
 - Veterinary Technologists (VTs)
 - Sampling and diagnostics
 - Veterinary Nurses (VNs)
 - o Companion animals in urban areas
 - Veterinary Physiotherapists (Vet Physio)
 - Companion animals and performing animals like horses
 - Laboratory Animal Technologists (LATs)
 - Research and development













Implementation and Impact

- Consultation and Promulgation
 - Public consultation process
 - Gazetting of new rules (December 2022, February 2023)
- Working for Own Gain
 - One of the most important features of the new rules is the creation of a new dispensation allowing VPPs to work for own account
 - This was a game changer in that for the first time in the history of the profession, VPPs can now register and operate their own para-veterinary facilities, as principals of such facilities
- Impact on Workforce and Animal Health
 - Addressing workforce challenges
 - Enhancing animal health across South Africa
 - Improving access to veterinary services by the rural smallholder farmer













SAVC Approved VPP Facilities to Date


New rules December 2022 and February 2023: Para-veterinary professionals can work for own gain to provide services within their scope of practice

- ✓ Primary animal healthcare facilities (AHTs) 21 facilities registered
- ✓ Veterinary nursing facilities four (4) facilities registered
- ✓ Veterinary physiotherapy facilities 26 facilities registered
- ✓ LATs and VTs- Zero (0) facilities thus far

Conclusion

- Veterinary Paraprofessionals (VPPs) play a pivotal role in enhancing veterinary services. Their expanded range of categories and increased authority to practice are directly linked to educational efforts aimed at upskilling. These advancements in training are reflected in the five (5) qualifications recognized by the South African Veterinary Council (SAVC) for VPP registration.
- The SAVC's regulatory changes ensure that VPPs meet contemporary standards necessary for delivering high-quality veterinary care. Effective communication between training institutions and the SAVC is essential for aligning educational programs with industry requirements and regulatory standards.
- This responsibility falls under the Education Committee (Educom) of the SAVC, which monitors educational institutions offering veterinary education to ensure curricula are updated according to current practices and regulations. To implement this new regulatory framework, Educom issued a notice to Veterinary Education Establishments (VEEs) to revise the Day One Competencies for VPPs, incorporating Business Development, Entrepreneurial Skills, and OneHealth.
- VEEs maintain ongoing communication with the SAVC through annual stakeholder engagements held by the Executive Committee and quarterly Educom meetings, where VEEs are represented.
