

SPECIALIST COMMISSIONS

- The core normative activities of the OIE are driven by the work of the four Specialist Commissions. The Terrestrial Animal Health Standards Commission and the Aquatic Animal Health Standards Commission are critical to the preparation and adoption of the science based standards in the respective codes
- The Biological Standards Commission focuses on the critical foundation to disease detection and control through recognised laboratory quality standards, diagnostic methods and appropriate vaccines



Specialist commissions cont

- The important work of the official recognition and maintenance of the disease status of member countries and the science based foundation to disease notification and control is undertaken by the Scientific Commission for Animal Diseases
- The competency, capacity and commitment of the duly elected members to these Commissions that determines the progression, scope, volume and the quality of the work that is able to be presented to the 180 member countries for comment and to the annual General Session for adoption.



Criteria for selection of candidates

- OIE GLOBAL CONFERENCE ON VETERINARY EDUCATION AND THE ROLE OF THE VETERINARY STATUTORY BODY 4 TO 6 DECEMBER 2013 BRAZIL.



Other activities of the Commission cont.

- DECLARATION OF DISEASE FREE AREAS TO THE OIE;
- -FMD
- -CBPP
- -PPR.....
- -Use of WAHIS for six months reporting
- -Timely responses through questionnaires sent to all Member Delegates
- -Implementation of the OIE Standards



Conclusions and Recommendations cont.

- Inclusion of the topic about the RAWS in other regions for the first time during the Regional Commission' conference is seen to be a step ahead towards African continental preparation of the RAWS
- Decline in participation in the annual General Assembly of Delegates which is held once a year in Paris
- Outstanding annual contributions by the Member states is creating a huge gap in decision making especially during voting for decision making



Conclusions and Recommendations cont.

- Africa has few representations on the specialized commissions and the 83rd General Session in May 2015 should be the time to plan ahead and agree on candidates.
- Common position meetings are important and Africa should always endeavour to speak, coordinate and implement the OIE standards holistically.
- Continuous annual declaration of animal disease free areas is very much encouraged "Prevention is better than cure"
